NOTICE OF RACE

ORGANIZING AUTHORITY

Fleet 85 of the International Lightning Class, in conjunction with the Niantic Bay Yacht Club, in accordance with the bylaws of the ILCA.

RULES

The regatta will be governed by "The Racing Rules of Sailing for 2021-2024," the prescriptions of US SAILING when they apply, the rules of the ILCA, and by the Sailing Instructions.

ELIGIBILITY AND ENTRY

Eligible boats (compliant with ILCA Rules) may enter by completing registration at Niantic Bay Yacht Club on Saturday June 26th before 11:00 am, or by mail prior to Saturday June 26th, sent to James Gardner, Regatta Chair (see contact info for address). The technical committee reserves the right to inspect boats for compliance with class rules including boat weigh-ins.

RADIO COMMUNICATION

Use of hand held VHF radios will be permitted for communication from the Race Committee to competitors on a predetermined channel to be identified in the Sailing Instructions. The Race Committee intends to use VHF radio to identify OCS (On Course Side) boats after starts and otherwise communicate with the fleet on the water. Failure to receive a hail, for a hail to be made, the order of hails made, or receive other communications to the fleet shall not be cause for redress.

FEES

Entry Fee will be \$120.00 per boat. Entry fee includes post race beverages and snacks. All fees are nonrefundable. Please make checks payable to <u>Lightning FLEET 85</u>.

SAILING INSTRUCTIONS

Sailing Instructions will be available at the Registration table and at the Skipper's meeting.

COURSES

The courses will be defined in the Sailing Instructions.

SCORING

The Low-point Scoring System, Appendix A of the racing rules, will apply. Six races are scheduled, of which one shall be completed to constitute a series. If five races are completed, each competitor's worst score shall be excluded.

PRIZES

Prizes will be awarded to the top three boats.

Sailors responsibilities

By participating in racing, a sailor acknowledges that he or she is solely responsible for his or her own safety and that of teammates and boat; that he or she represents that the boat and its equipment are in sound condition and all required safety equipment is aboard, accessible for use and in operable condition; that the decision to race, not to race, or to withdraw after starting is solely his or hers; and he or she hereby releases the organizing authority, its officers, trustees, and all members of the Race Committee, whether or not members of the organizing authority, from any and all liability or claims for personal injury or property damage or death resulting in participation in this event to the fullest extent permitted by law.

I agree that this waiver is binding on my heirs, representatives, successors and assigns.
