**Entry/Registration:** The event is open to Lightning Class sailboats. Eligible boats may enter by completing the online entry form at <a href="https://club.severnsailing.org/event/587">https://club.severnsailing.org/event/587</a> and paying a registration fee of \$50 prior to 0930 on May 15. No on-site registrations will be accepted. This changes SSA SI 5.1. Boats may be raced with 2 people.

All persons (skippers and crew) must sign a COVID-19 waiver and abide by the Seven Sailing Association policies, i.e., social distance, wear face coverings on the lot and in the building, and come to SSA only if you are healthy with no symptoms of COVID-19, have been healthy and symptom-free for the past two weeks, and have not been exposed to anyone with COVID-19 symptoms in the past two weeks. On Sunday, the Lightnings are encouraged to launch by 10:00 to avoid congestion on shore with the Laser Fleet which will start one hour after the Lightnings, at 12:00.

Due to COVID-19 restrictions, there will be no breakfast. Lunches are not available at the snack bar.
